RESOLUTION

A RESOLUTION SUMMARIZING EXPENDITURES AND REVENUES FOR EACH FUND AND ADOPTING A BUDGET, LEVYING PROPERTY TAXES FOR COLLECTION IN THE YEAR 2023 TO HELP DEFRAY THE COSTS OF GOVERNMENT, AND APPROPRIATING SUMS OF MONEY TO EACH FUND IN THE AMOUNTS AND FOR THE PURPOSES SET FORTH HEREIN FOR THE VILLAGES AT CASTLE ROCK METROPOLITAN DISTRICT NO. 9, OF DOUGLAS COUNTY, COLORADO, FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY, 2023, AND ENDING ON THE LAST DAY OF DECEMBER, 2023.

- A. The Board of Directors of the Villages at Castle Rock Metropolitan District No. 9 has authorized its budget officer to prepare and submit a proposed budget to said governing body at the proper time; and
- B. The proposed budget has been submitted to the Board of Directors of the District for its consideration; and
- C. Upon due and proper notice, published in accordance with law, said proposed budget was open for inspection by the public at a designated place, a public hearing was held on December 5, 2022, and interested electors were given the opportunity to file or register any objections to said proposed budget; and
- D. The budget being adopted by the Board has been prepared based on the best information available to the Board regarding the effects of Article X, Section 20 of the Colorado Constitution; and
- E. Whatever increases may have been made in the expenditures, like increases were added to the revenues so that the budget remains in balance, as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE VILLAGES AT CASTLE ROCK METROPOLITAN DISTRICT NO. 9 OF DOUGLAS COUNTY, COLORADO:

- 1. <u>Summary of 2023 Revenues and 2023 Expenditures</u>. That the estimated revenues and expenditures for each fund for fiscal year 2023, as more specifically set forth in the budget attached hereto, are accepted and approved.
- 2. <u>Adoption of Budget</u>. That the budget as submitted, amended and attached hereto and incorporated herein is approved and adopted as the budget of the Villages at Castle Rock Metropolitan District No. 9 for fiscal year 2023.
- 3. <u>Levy of Property Taxes.</u> That the foregoing budget indicated that the amount of money necessary to balance the budget for the General Fund for operating expenses from property tax revenue is $\frac{701}{480}$ and that the 2023 valuation for assessment, as certified by the Douglas County Assessor, is $\frac{7,480}{480}$. That for the purposes of meeting all general

operating expenses of the District during the 2023 budget year, there is hereby levied a tax of 91.198 mills upon each dollar of the total valuation of assessment of all taxable property within the District for the year 2022.

- 4. <u>Levy of Debt Retirement Expenses.</u> That the foregoing budget indicated that the amount of money necessary to balance the budget for the Debt Service Fund for debt retirement expense from property tax revenue is $\underline{\$0}$ and that the 2023 valuation for assessment, as certified by the Douglas County Assessor, is $\underline{\$7,480}$. That for the purposes of meeting all debt retirement expenses of the District during the 2023 budget year, there is hereby levied a tax of $\underline{0.000}$ mills upon each dollar of the total valuation of assessment of all taxable property within the District for the year 2023.
- 5. <u>Certification to County Commissioners</u>. That the Secretary of the District, is hereby authorized and directed to immediately cause to have certified to the County Commissioners of Douglas County, the mill levy for the District hereinabove determined and set forth on the Certification of Tax Levies for Non-School Governments attached hereto.
- 6. <u>Appropriations</u>. That the amounts set forth as expenditures and balances remaining, as specifically allocated in the budget attached hereto, are hereby appropriated from the revenue of each fund, to each fund, for the purposes stated.
- 7. <u>Budget Certification</u>. That the budget shall be certified by the Secretary or Assistant Secretary of the District, and made a part of the public records of the Villages at Castle Rock Metropolitan District No. 9.

Attached please find a copy of the adopted 2023 budget for Villages at Castle Rock Metropolitan District No. 9.

The Villages at Castle Rock Metropolitan District No. 9 have adopted a budget for one fund, a General Fund to provide for the payment of general operating expenditures.

The district's accountants have utilized the modified accrual basis of accounting and the budget has been adopted after proper postings, publications, and public hearing.

The primary sources of revenue for the district in 2023 will be developer advances. The district intends to impose a 91.198 mill levy on the property within the district for 2023, which will be dedicated to the General Fund.
